



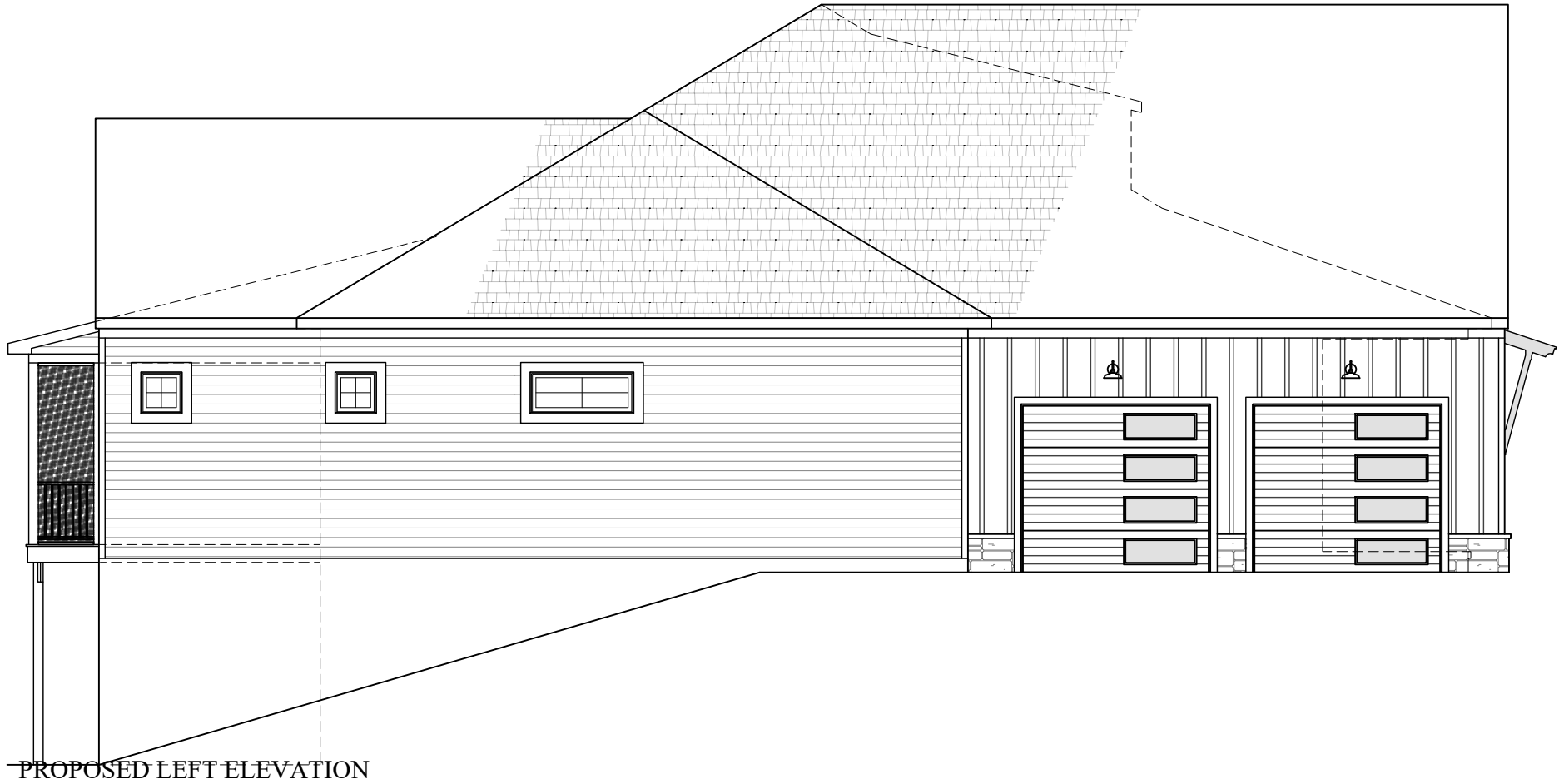

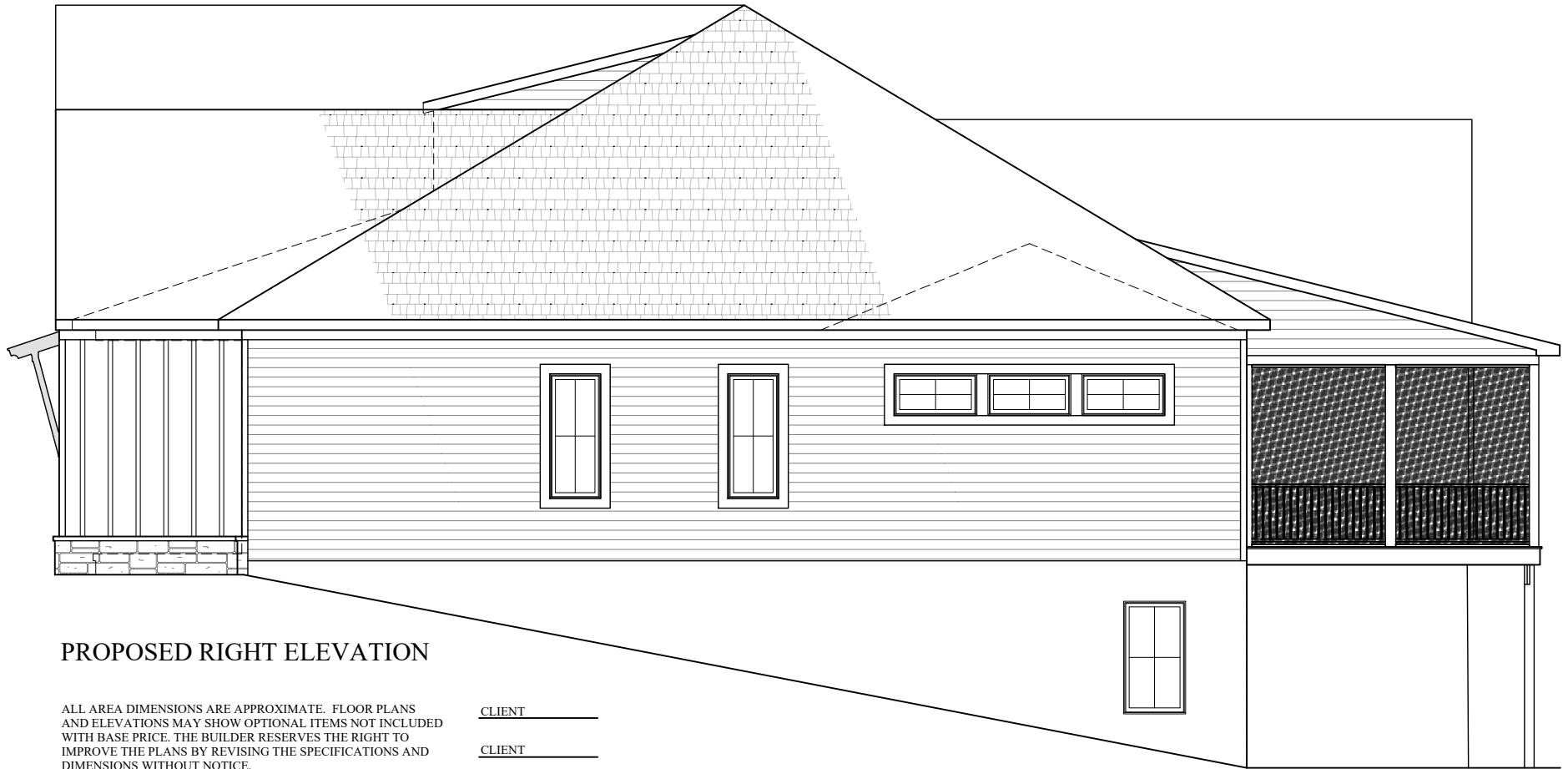
PROPOSED LEFT ELEVATION

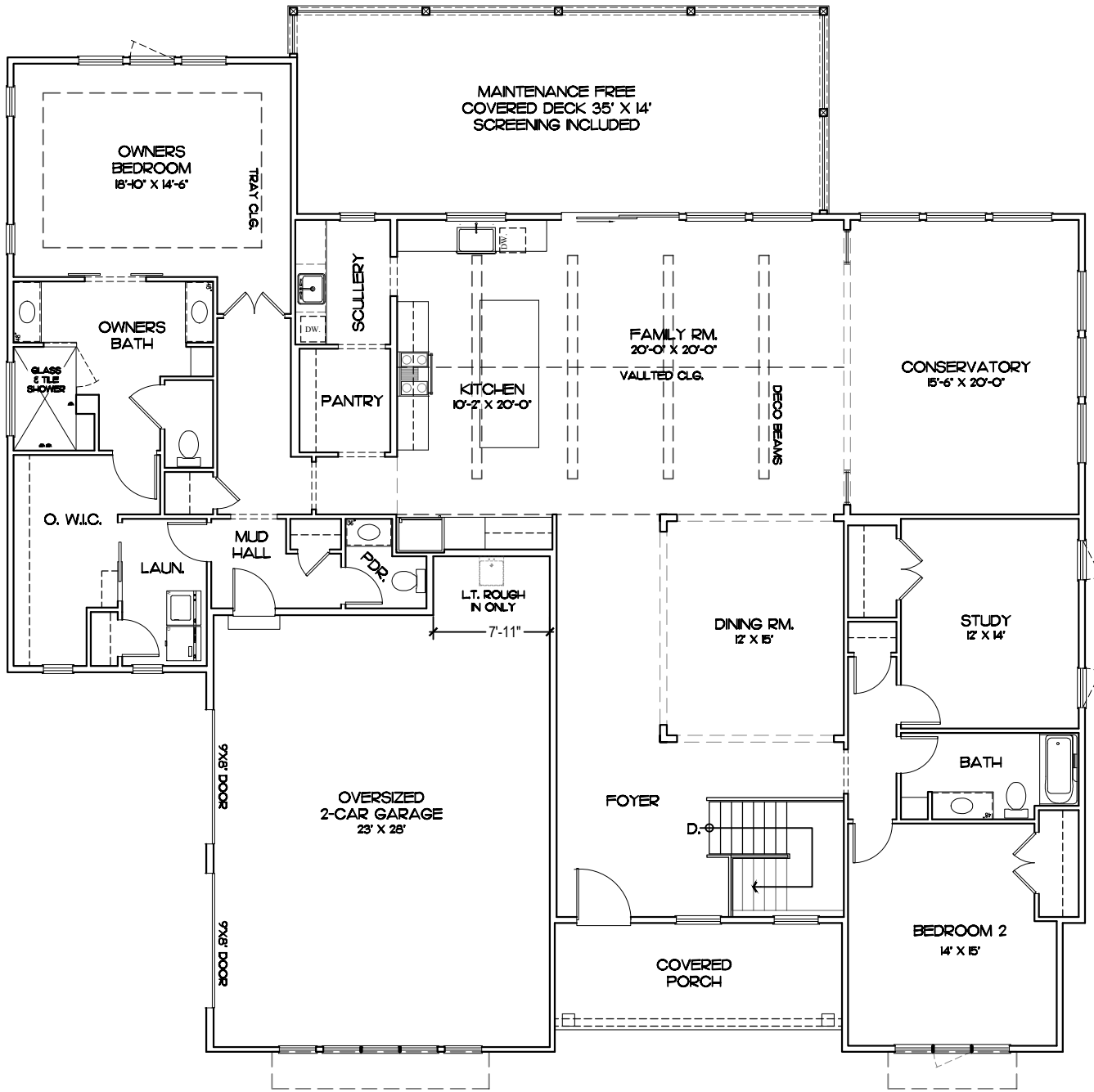

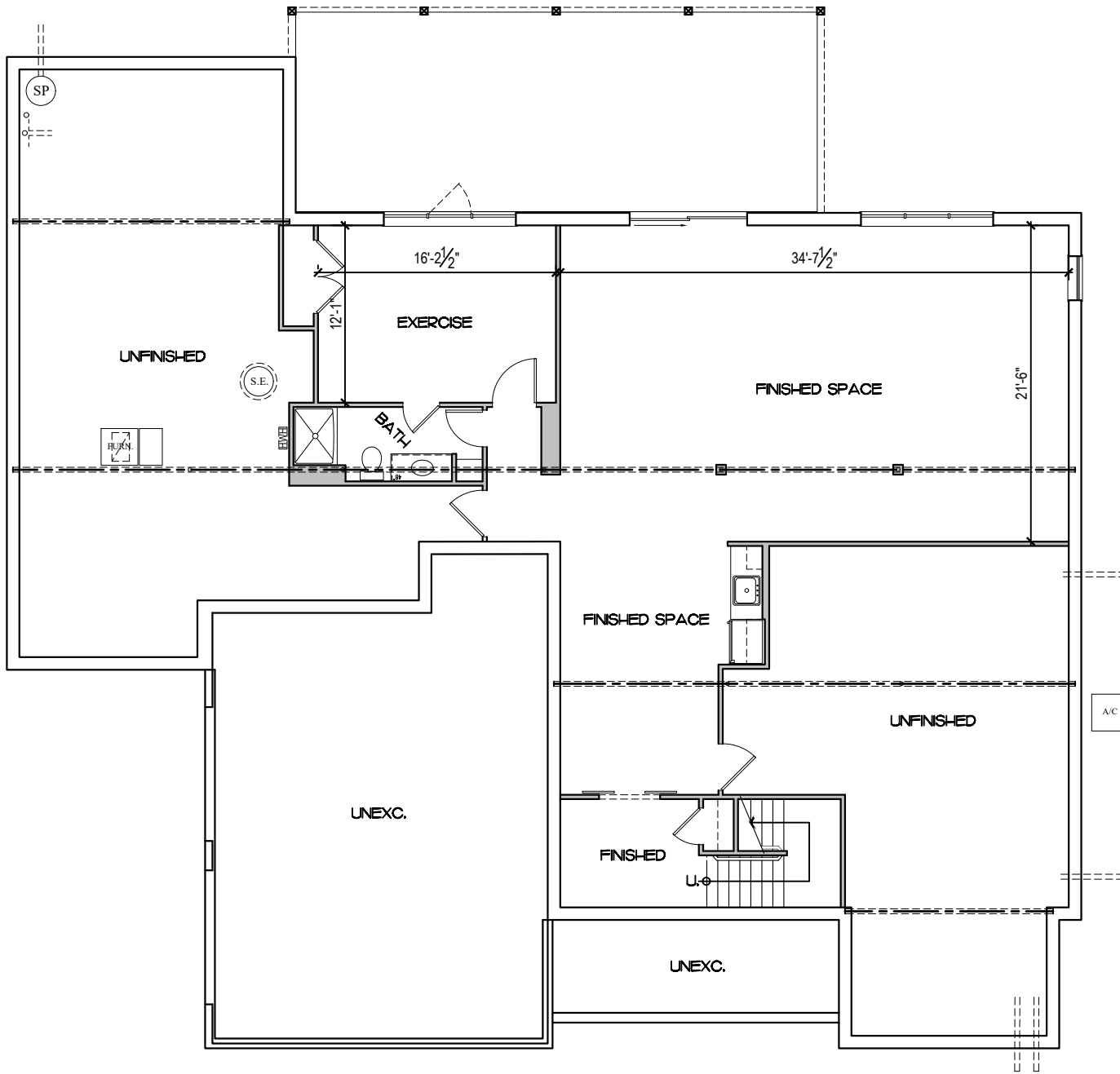
